Executive Director

The Buckeye State Funeral Directors & Embalmers Association will hold its 75th Annual Convention in Columbus, June 21st through 23rd. The Board will have an exhibitor booth at the Convention. In addition to board staff, Ty Marsh will attend the Convention as a representative of the board.

Since speaking with Marc Myers, of Blaugrund, Herbert, Kessler, Miller, Myers & Postalakis, on May 17th and asking him to work toward the 30 day timeframe for providing hearing report and recommendations, we currently have no report and recommendations outside of the timeframe.

The Board offices will be closed Wednesday, July 4th in observation of Independence Day.

Our next meeting will be July 16th through 17th, in Columbus, Ohio. We will begin this meeting with electing our new officers for the 2012/2013 year.

The Inspectors have been provided with new touch screen laptops. Our goal is to move toward an electronic inspection process.

Mrs. Vanessa Niekamp has continued discussions with the Cosmetology Board and the Bureau of Motor Vehicles on a project to provide state issued identification cards

to licensees.

Mrs. Vanessa Niekamp is working with DAS IT staff, to update the board's website.

Mrs. Vanessa Niekamp has begun the process to move to an online renewal process for December 2014.

Mrs. Vanessa Niekamp has been working with the Office of Budget and Management (OBM) regarding our fee increases and need for additional appropriation in SFY13 and beyond. Per their direction, Mrs. Niekamp will be presenting a request for an increase of appropriation in August for SFY13. OBM will include the fee increases and associated revenue in the Budget Bill for SFY14 and SFY15. We will then be able to hire an additional inspector in July 2013. Licensee fees will not increase until the December 2014 renewal period.

Mrs. Vanessa Niekamp included a copy of HB481 as passed by the Ohio House (without the Alkaline Hydrolysis language) for review. This information was also emailed to the Board members on Monday, June 11, 2012. The Legislature will be out most of the summer and the bill will not be taken up again until the fall. OFDA would like to meet with interested parties to discuss suggested amendments to the bill. Possible meeting dates are being compiled. In addition, we are being asked by OFDA if we will come out in support of licensing Alkaline Hydrolysis (are we in favor or opposed).



Mr. Robert Carter reported on the meeting he attended at The Conference regarding the revamping of the National Board Exam.



The committee will recommend approval of all continuing education applications and one exemption application.


Mrs. Williams-Briggs is prepared and ready to provide a report to the Board.
